


THIS SUPPLEMENTARY AGREEMENT (“this Agreement”) is made the 19TH day of November 2018 between **HER MAJESTY’S GOVERNMENT OF GIBRALTAR (“HMGOG”)** and the **MOTOR INSURERS’ BUREAU (“MIB”)** whose registered office is Linford Wood House, 6-12 Capital Drive, Linford Wood, Milton Keynes MK14 6XT.


IT IS HEREBY AGREED AS FOLLOWS:-

1. This Agreement is supplementary to the Uninsured Drivers Agreement dated 3rd May 2001 and made between HMGOG and MIB (“the 2001 Agreement”).
2. This Agreement shall come into force on the date above-written. The 2001 Agreement shall continue to apply in all respects save as provided for by the amendments set out below.
3. A new Clause 6(1)(f) is inserted with the following wording:
“a claim arising out of a Relevant Liability incurred by the user of a vehicle which is covered whether through contract, statutorily or otherwise, by a contract of insurance but where such liability cannot be met by the insurer in question due to it having insufficient funds or it being in insolvency.”
4. For the avoidance of doubt, paragraph 3 above applies to a claim which arises from an accident occurring either before or after the date referred to in paragraph 2, provided that the insufficiency of funds or insolvency arises on or after that date.
5. This Agreement may be executed in two counterparts with the same effect as if both parties execute a single document.



IT IS HEREBY AGREED AS FOLLOWS:-


1. This Agreement is supplementary to the Untraced Drivers Agreement dated 4th April 2003 and made between HMGOG and MIB (“the 2003 Agreement”).
2. This Agreement shall come into force on the date above-written. The 2003 Agreement shall continue to apply in all respects save as provided for by the amendments set out below.
3. A new Clause 5(1)(h) is inserted with the following wording:
“Where the claim is covered, whether through contract, statutorily or otherwise, by a policy of insurance but where such liability cannot be met by the insurer in question due to it having insufficient funds or it being in insolvency.”
4. For the avoidance of doubt, paragraph 3 above applies to a claim which arises from an accident occurring either before or after the date referred to in paragraph 2, provided that the insufficiency of funds or insolvency arises on or after that date.
5. This Agreement may be executed in two counterparts with the same effect as if both parties execute a single document.
